5. CURRICULUM

A) MATHEMATICS & STATISTICS

a) New Courses

- i) DANA 4800 Data Analysis and Statistics
- ii) DANA 4810 Predictive Analytics Quantitative Data
- iii) DANA 4820 Predictive Analytics Qualitative Data

These courses were developed for the new Post Degree Diploma in Data Analytics, and cover different approaches to data management. Registration is restricted to students in the Data Analytics program.

IT WAS MOVED by M Heldman, seconded by S Bowers that the new courses DANA 4800 – Data Analysis and Statistics, DANA 4810 – Predictive Analytics-Quantitative Data and DANA 4820 – Predictive Analytics – Qualitative Data be approved by Education Council.

iv) MATH 4801 – Mathematics for Data Analytics

This is a self-paced, 1-credit course that will provide students with the foundation in mathematics needed to be successful in the Post Degree Diploma in Data Analytics. Registration is restricted to students in the Data Analytics program.

IT WAS MOVED by L Cullen, seconded by S Bowers that the new course *MATH 4801 – Mathematics for Data Analytics* be approved by Education Council.

B) COMPUTER SCIENCE & INFORMATION SYSTEMS

a) New Courses

- i) CPSC 4800 Computing for Data Analytics
- ii) CPSC 4810 Transformations for Data Analytics
- iii) CPSC 4820 Visualization for Data Analytics

These courses were designed as a 3-stage workflow series for managing data. Registration is restricted to students in the PDD in Data Analytics program.

IT WAS MOVED by M Heldman, seconded by R Macqueen, that the new courses *CPSC 4800 – Computing for Data Analytics, CPSC 4810 – Transformations for Data Analytics* and *CPSC 4820 – Visualization for Data Analytics* be approved by Education Council.

C) HEALTH SCIENCES

a) Course Change

i) HSCI 2215 – Perspectives on Disability and Injury

The Health Sciences department recommends reinstating the final exam in this course, effective the 201910 semester. The final exam will be worth 25% of the student's course grade.

ii) GEOG 1105 – Field Techniques

This request was submitted to allow an immediate, temporary change in grading method from S/U to letter grade, with a minimum passing grade of "D" effective for the current semester. A proposal for a permanent grading change will be presented at the June 2018 meeting of Education Council. This course is taught once a year during the summer semester.

A) CONTINUING STUDIES

a) New Program

i) Balance System of Acupuncture Certificate Program

This program provides training that combines classical and modern approaches in acupuncture. The curriculum consists of 8 required courses, for a total of 95 program hours.

APPENDIX B

EDUCATION COUNCIL MEMBERSHIP

The College and Institutes Act (1996) defines the composition of Education Council in Section 15 (membership) and Section 17 C (election rules reflecting distribution and representation). To reflect the 2018 reorganization of the academic faculties, the 10 faculty positions are apportioned as follows:



5 voting Division Chairs Alternate chairs from Creative Arts and Industries & Humanities Applied Sciences & Math/Sciences Community Programs & Social Sciences 1 each from Nursing and Management 1 Library/Counselling 4 at large

It was noted that Division Chairs not currently in a voting role on EdCo would be expected to attend meetings and participate in discussions.

An alternative option had been discussed by the ad hoc committee, and circulated to Education Council members by email. This option would allow all 8 Division Chairs a voting membership on Council but only 1 "at large" position. In both options, representation by students, staff and administrators is unchanged, and the total number of voting members is unaffected.
