## 4. CURRICULUM

## 4a) PHYSICS

## Program Revision

i) Arts \& Science (Engineering) Certificate
M. Heldman presented the program revision. The Physics department requests changing the admission requirements from LET 4 to LET 3 and from three A's in Chemistry 12, Mathematics 12, and Physics 12 to two A's and one B in those courses.

## Change to Course Prerequisites

ii) PHYS 1118 - Introductory Physics

The department requests a change to the course prerequisites, to be implemented in January 2004. The present prerequisites are: Mathematics 12 or MATH 1152 with a "C" or higher or MATH 1153 or MATH 1170 concurrent and Physics 11 or PHYS 1114 with a "C" or higher.

The new course prerequisites are: Physics 11 (BCSecS) with a "B" or higher or PHYS 1114 with a "C" or higher or Physics 12 with a "C "or higher or satisfactory score on Physics Diagnostic Test and Mathematics 12 or MATH 1152 with a "C" or higher or MATH 1153 or MATH 1170 concurrent.

iii) PHYS 1125
M. Heldman advised that the Physics department requests a change to the course prerequisites, to be implemented in January 2004. The present prerequisites are: Physics 12 or PHYS 1118 with a "C" or higher or PHYS 1115 and 1215 and MATH 1171 or MATH 1173/1183 (preferred) or MATH 1253 concurrent.

The new course prerequisites are: Physics 12 (BCSecS) with a "B" or higher or PHYS 1118 with a "C" or higher or satisfactory score on Physics Diagnostic Test and MATH 1171 or MATH 1173/1183 (preferred) or MATH 1253 concurrent.

## 4b) MATH

Change to Course Prerequisites
i) MATH 1171 - Calculus 1

## 4c) IDS - LATIN AMERICAN STUDIES

## New Course Proposal

i) LAMS 2206 - Latin America in a Globalized World
R. Semmens presented this new course proposal. This course will explore how globalization and policies of financial, trade and investment liberalization are affecting Latin America and will examine the role played by international institutions and multilateral organizations in shaping the political economy of the region.

It was noted that the Economics department used to offer a similar course; however, that course was discontinued. Therefore, it is important for IDS to offer this proposed course for its students.

## 4f) EDUCATION ASSISTANT

## Program Revision

i) Education Assistant Program

The department requests the following changes be made to the academic and the program requirements:
"Academic requirements: Completion of Grade 12 or equivalent. If you do not have BC Grade 12 or equivalent and you are at least 19 years of age, you may be accepted provided you have a minimum of 3 credits of university transferable courses with a grade point average of 2.0 or higher.

Program requirements: Have recent volunteer or work experience with students with disabilities. Preference will be given to applicants who have 100 hours of recent volunteer experience with children with disabilities in school or related settings.

A minimum of two recent letters certifying that volunteer experiences were successful are required. Note: Letters from relatives or friends are not acceptable."

The department has also added a Criminal Records Review to the admission requirements. Discussion followed pertaining to the Criminal Records Review.
