## 4. CURRICULUM

## 4a) MATHEMATICS

Change to Course Prerequisites
i) MATH 2373 - Real Analysis

The Mathematics department requested changing the course prerequisites for this secondyear Mathematics course on Real Analysis from

MATH 1171 or MATH 1173 with a 'B' grade or higher (or consent of the instructor), and MATH 1271 or 1273 (may be taken concurrently).

MATH 1271, MATH 1273 or MATH 1274, OR permission of the department.

"Priority registration will be given to Collaborative Nursing students ..."

## ii) BIOL 2350 - Comparative Vertebrate Anatomy

"BIOL 1215 (or equivalent) with a minimum of ' $\mathrm{C}+$ ' OR any second-year Biology course with a minimum of ' $\mathrm{C}+$ '.

## 4c) CHEMISTRY

Change to Course Prerequisites
i) CHEM 2250 - Physical Chemistry

to
"CHEM 1220 and one of the following: MATH 1171, 1174, 1253, or the combination of 1173 and 1183. MATH 1271 or the combination of MATH 1273 and 1183 are recommended."

## 4d) MODERN LANGUAGES

Change to Course Prerequisites
i) CHIN 1115, 1215, 1117, 1217, 1125, 1225

The Modern Languages department requested changing the course prerequisites for the above courses. R. Semmens went through the changes as described on page 21 of the agenda package. The effect of the changes is to ensure that over-qualified students do not take these courses.

## 4e) CRIMINAL JUSTICE

Program Revision
i) Criminal Justice

The Criminal Justice department requested to have inserted in the calendar that graduation from the program requires a minimum of ' C ' in each course. The proposed wording (in bold) is:

> "Program students must complete all courses in each term with a minimum of a ' $C$ ' in order to enroll in the following term. In some cases, prior written approval may be granted by the department chair to permit a student to advance to the next term. Students who are given a waiver will be required to repeat the course to obtain the minimum ' $C$ ' for graduation."

## 4f) ECONOMICS

## Minor Course Revision <br> i) All courses offered by the Economics department

The Economics department requested raising the maximum weight of final exams from $35 \%$ to $40 \%$ for all courses offered by the department.

The reasons are:
a) A higher limit will give students who have done poorly in their first midterm a second chance to succeed.
b) Most of the department's courses transfer directly to university courses where the weighting of the final exam is $40 \%$ or more.
c) A higher limit will give instructors in the department more flexibility in organizing their course assessment. In particular, the change will allow instructors to better match the weight of the finals to their importance.

Discussion followed. Comments received from the members were:

- That raising the maximum weight of final exams to $40 \%$ in all the courses in the Economics department would constitute a departure from the College standard.
- Students who are not good at examinations will be disadvantaged by raising the maximum weight of final exams.
- Examination requirements vary from discipline to discipline.
- On the attachment to the minor course revision form, point 2, only ECON 1220, 1221, 2210, 2296 and 2297 were compared to UBC's and SFU's final exam weight limit.
- It would be a good idea to include a breakdown of all the course assignments and assessment format in the department.

MOTION: That this minor course revision to raise the maximum weight of final exams from $35 \%$ to $40 \%$ for all courses offered by the Economics department be approved as recommended.

These courses were part of the old program and are no longer offered in the revised program; therefore, the Recreation department requested discontinuing RECR 2489, 2479, 2398, and 2379.

## Program Revision

## v) Leisure Studies Diploma

The purposes of this program revision are:
a) to adjust the current Leisure Studies Diploma to reflect better transfer suitability to Canadian recreation and leisure study university programs
b) to adjust the current Leisure Studies Diploma to allow students to transfer from the revised Recreation Diploma Program after their third term, and complete the Leisure Studies Diploma in their fourth term.

Discussion ensued regarding the six credit hours in English. It was agreed that the wording needs to be changed to reflect the department's intention that English will be the university transferable English courses. P. Novak Cawley will follow up with T. Paradis and K. Tisshaw with regard to the change in the wording.

## 4h) NURSING

## Program Revision <br> i) Collaborative Nursing

Due to the closure of the diploma RN option, Nursing students with stronger academic qualifications are required to ensure success in the BSN (Bachelor of Science in Nursing) program. The Nursing department is aligning the admission requirements with expected performance in course work. Applicants must satisfy requirements in each of five subject areas (English, Biology, Chemistry, Math and a third Science). Details as follows:

An official transcript indicating the degree awarded must be submitted.

## 7. POLICY: ACADEMIC STANDING - ACADEMIC PROBATION AND

 ACADEMIC SUSPENSIONV. Magee Shepherd advised that Education Council approved this policy on May $13^{\text {th }}$. When this policy was reviewed by the President after Education Council had approved it, several changes were suggested. The policy has been re-written, and while the original foundations remain, the wording is significantly changed from what was approved in May.

The following changes (as underlined) were made:

## 2. DEFINITIONS

- Dean means the Dean of Student and Education Support Services.
- Good Standing is the status of a student who is not on Academic Probation or Academic or other suspension.
- Minimum Academic Standard means a semester grade point average of at least 1.50 and no more than one letter grade of "F", "N", "U" or "W".

5. POLICY
5.2 "... for the most recently completed semester at Langara College ..."

## 8. PROCEDURES

Second Suspension
8.9 Students on a second Academic Suspension will not be permitted to register for the following six semesters.

## Third Suspension

8.13 Students on a third Academic Suspension will not be permitted to register for the following nine semesters.
8.15 "... The Registrar will establish the maximum number of credits that the student
will be permitted to register in."
Discussion followed.
