#### **3.** APPROVAL OF THE PREVIOUS MINUTES AND BUSINESS ARISING On Page 3, 4c) CHEMISTRY

# 8. FOR INFORMATION

## CCAP 1113 for International Students

L. Cullen introduced C. Nobles, coordinator of the CCAP program to present this item.

C. Nobles advised that CCAP is piloting a condensed CCAP 1113 course to incoming international students in the summer and fall semesters in 2004. International students are strongly encouraged to take this course. This compressed regular CCAP 1113 course will be taught in a 3-week segment, commencing in April and August, and is especially for the new international students coming from overseas. These students normally arrive 4 weeks before their semester commence, they will be attending orientation, registering in their normal registration time and will start this course the following week.

P. Novak Cawley turned the chair to M. Gerson while she presented the following:

## 5. PROGRAM REVIEW – Human Performance

P. Novak Cawley presented the program review for the Human Performance department. A document detailing this program review was distributed with the agenda package.

#### 7. APPLIED DEGREE DEVELOPMENT PROCESS

M. Gerson spoke to this topic. Concerns were expressed at the September 24<sup>th</sup> Chairs lunch workshop about the amount of work involved prior to step 2 as described in the previous draft. M. Gerson then referred to Draft 3 of the Applied Degree development process, which was distributed with the agenda package, incorporating the changes suggested at that lunch meeting.

Addressing the concerns, the proposed changes (in italics) were made:

- Ministry Step 3 Full Program proposal submitted to *Degree Quality Assessment Board (DQAB)* for approval.
- Internal Procedure
  - Step 1 "... puts together a draft *framework for an* Executive Summary..."
  - Step 1 "Departments should consult with advisory committee, *division Chair, and dean* in developing this proposal."
  - Step 2 Criteria regarding factors internal to the College:
    - second bullet point *initial indications* of cost of delivery Criteria regarding factors external to the College
    - first bullet point *initial indications of labour market* needs/trends, including international portability
    - fourth bullet point *initial indications of* student demand *with description of how such demand may be confirmed*...
- New Step 3 Dean takes DDC priorities to Executive for approval in principle. Depending on work required at step 4, some resources from Strategic Development Fund may be made available at this point.

This 2-page document captures a 13-step process to be followed for the approval of the new Applied Degree programs and it matches with the Ministry's process. Discussion followed.

**MOTION:** That the Applied Degree development process be approved as recommended.

# 8. FOR INFORMATION (cont'd)

## • Dietetic Canadian Experience Program (DCEPE)

L. Cullen spoke to this topic. She updated members on the Dietetic Canadian Experience Program (CEP). The Community, Aboriginal and Women's Services Ministry agreed to fund a pilot project, in conjunction with Langara College and the British Columbia Dietitians and Nutritionist Association (BCDNA), to develop a program that would provide the practical training necessary for foreign-trained dietitians to be eligible to register with the provincial regulatory body and practice dietetics in Canada. There are two phases for this program.

The initial proposed start up for phase two was September 2003 but while Langara was ready to go, some difficulties were encountered with respect to the provincial regulatory body and the actual number of candidates eligible to complete the practical experience. The proposed start for the first DCEP intake is now scheduled for mid-February 2004.

The goal is to offer both phases on a cost recovery basis, on the longer term, if both phases of the pilot are successful; the plan is to integrate the DCEP program on a more permanent basis into the Coop Department. It was noted that this pilot project is the only one in Canada at the present time, to be developed on a cost recovery basis.

#### 9. OTHER BUSINESS

• Adding the TWE score to our TOEFL requirements for International Education students

The following is a recommendation for approval from the Arts & Science Admissions Review Committee:

"Addition of the TWE score to our TOEFL requirements for International Education Students.

The Test of Written English (TWE) portion of Test of English as a Foreign Language (TOEFL) will be included in the TOEFL requirements for international education students. IE students using the TOEFL to meet Langara's English language proficiency requirement for admission must now have a TOEFL score of 4 on the TWE portion of the test and 550 or higher on the paper-based test, or 213 or higher on the computer-based test.

Acceptance of a score of 60 overall and 60 in the writing portion of the Canadian Academic English Language Assessment (CAELA) test to meet Langara's English language proficiency requirement for IE students."

It was noted that the above requirements are in addition to the existing requirements. Discussion followed.

**MOTION:** That the addition of the TWE score to the TOEFL requirements for Langara international education students be approved as recommended.
