## 4a) NURSING

## Change to Course Prerequisites

i) NURS 2250 - Healing I: Episodic Health Challenges
ii) NURS 2140 - Nursing Practice III

The Nursing department proposed adding ENGL 1129 and ENGL 1130 as prerequisites to NURS 2250 and NURS 2140 for Term 3 of the Nursing program.

## 4b) BUSINESS MANAGEMENT

## Minor Course Revision

i) BCAP 0012 - Computer Basics I
ii) BCAP 1112 - Computer Bascis II

The Business Management department proposed a change in the calendar description for BCAP 0012 and BCAP 1112 to reflect the updating of operating systems and software packages.

## 4c) COMPUTER SCIENCE

M. Heldman presented the changes to the offerings of Computer Science courses. A. Bagheri, chair of the Computer Science department, was invited to this meeting to answer any questions that might arise.

## iii) Change to course prerequisites (all courses)

The Computer Science department proposed removing the English language requirements from all Computer Science (CPSC) courses.

Considerable discussion followed. R. Semmens spoke against the motion citing its timing and the effect it would have on student literacy as significant concerns.
M. Heldman spoke to the motion. She advised the other prerequisites for the Computer Science courses are still in place. There are five departments in the Mathematics \& Sciences division, and the majority of these departments do not have English prerequisites for their courses. The removal of the English prerequisites would bring the Computer Science department in line with the offerings in the division. She added that the Computer Science courses offered at SFU, UBC, Capilano College, Douglas College and Kwantlen College also do not have English prerequisites. In the department's experience, overriding students with appropriate Computer Science background into CPSC courses without the required English prerequisite, has been successful. Students are successful in completing Computer Science courses even though not all have the English prerequisite.

## Program Revision

- adding two Communications courses - CMNS 1118 or CMNS 1115 - to the English requirements in term 3

It was suggested that the lines "and less than 5 in English usage" that appeared under "Note" on p. 17 of the agenda package be deleted.

## New Course Proposal

## i) LIBR 1395 - Special Topics: Creating \& Managing Digital Collections

L. Cullen spoke to this topic. The Library \& Information Technology department proposed adding this new course to keep their special topics offerings relevant by meeting the changing needs and demands in the library workplace.

ii) Library \& Information Technology - Regular Program \& Flexible Participation Option The Library \& Information Technology department proposed the following change in the Academic Elective requirements for the Library \& Information Technology Diploma for students who already hold certain Bachelor's degrees:
"Students in the Library and Information Technology program holding a Bachelor of Arts or Sciences degree from an accredited Canadian University, with an overall minimum GPA of 2.0 in that degree, may transfer in from that degree any 9 credits in Arts or Science in which a minimum grade of $C$ - was achieved, to meet the academic electives of the General or Technology Stream."

## Change to Course Prerequisites

## i) CRIM 1117 - Introduction to Control Tactics

"CJUS 1217 with a S grade (may be taken concurrently with CJUS 1117) or proof of completion of Basic Security Training 1 (BST1)."

R. Semmens reported that L. Arnold, he and K. Seveinson are working on a new field studies project in Haida Gwaii. Langara College received a grant from the Ministry of Advanced Education under the Aboriginal Special Project Fund for the Haida Gwaii Field Studies Program. This program will be launched in May 2005.

MOTION: That the Haida Gwaii Field Studies Program be approved by Education Council in principle.
