# 1. CALL TO ORDER

The meeting was called to order at 1300 hours.

# 2. APPROVAL OF AGENDA

#### 4. Bachelor of Business Administration

Draft Applied Degree Proposal Draft Notice of Intent

- L. Cullen referenced the Draft Bachelor of Business Administration Applied Degree Proposal and Draft Notice of Intent, attached in the agenda package from p.7 117, which were put together by P. Norwood and G. McFarlane on behalf of the Financial Management and Business Management departments. She invited Peter and Gordon McFarlane to speak to the proposal.
- G. McFarlane advised that he and P. Norwood will continue to work on formatting, editing and fine-tuning the wording of the proposal in May. It is anticipated that the course outlines will be presented to Education Council for its consideration in the fall. Gordon reiterated that this proposal has been strongly supported by Langara students, the business community and the professional accounting associations. There is a strong demand for Langara College to offer an applied business degree.

**MOTION:** That Langara Education Council approve, in principle, the Bachelor of Business Administration proposal, as embodied in the Draft Full Program Proposal and Draft Notice of Intent, recognizing that both of these documents are still subject to further refinement of wording prior to being submitted to the Ministry and to the Degree Quality Assessment Board.
