4. **CURRICULUM**

A) CONTINUING STUDIES

Certificate Programs

- Airline and Travel Service Agent Certificate
 - a) Airport Check-in Agent stream
 - b) Travel and Tourism stream

I. Humphreys gave a brief description of this new program, which will provide students with the skills needed to obtain careers in the airline and travel service industry. He noted that the Airport Check-in stream is already full with 20 students enrolled.

 - a) <u>Financial Management</u> <u>Prerequisite Change</u>
 - i) FMGT 4225 Advanced Taxation

L. Cullen explained that this change was being presented as an amendment to incorrectly listed prerequisites, which should be FMGT 1321 with a minimum C- grade and FMGT 2325 with minimum C- grade.

 - D) HUMANITIES
 - a) <u>IDS</u>

Program Revision

- i) Environmental Studies
- R. Semmens explained that most changes are a matter of housekeeping with a total of 7 courses removed from the list either because the course number had been changed or because the course was deemed inappropriate for the program. In addition, certain new courses have been added, including Aboriginal Studies. Care was taken to ensure there is a good transition plan in place for current students. Changes are to become effective 200710, with the exception of the course deletions, which will come into effect 200730.

5. BUSINESS ARISING

i) Course Credit: Special Consideration

J. Hooton noted that when this document was originally presented to Education Council on September 19, 2006, there had been concern raised over Paragraph 5.4, relating to a student's ineligibility to receive this type of credit in clinical placements, practica, etc. The statement has now been revised to address those concerns. There was a brief discussion regarding the timeline for implementation of the policy.

MOTION:

That Education Council approve the Course Credit: Special Consideration policy as presented in the agenda package, to be implemented no earlier than 200710.

6. NEW BUSINESS

i) B.C. Provincial Exams

K. Paul presented this topic, explaining that the provincial government's 2004 graduation program making provincial examinations optional will come into effect with the Grade 12 students graduating in 2007. At the Deans and Division Chairs meeting of November 8, 2006 a memo was circulated entitled "B.C. Grade 12 Provincial Examinations" which contained an analysis of Langara's current admission requirements as well as the implications and options available to Langara as a result of this policy. It was determined that retaining current admissions practices would not cause significant operational changes, however will demonstrate a certain standard worth preserving. Thus a motion was passed stating "that provincial exams are required to support a particular grade when that grade is being used toward satisfying an admission requirement or prerequisite."

MOTION:

That Education Council approve the motion passed by the November 8, 2006 meeting of Deans and Division Chairs, as stated above.

ii) Adjustment to Examination Dates for 200710

K. Paul explained that the original schedule contained only 6 examination days instead of the usual 7. The proposed change requires the elimination of one formal study day, but allows the additional day for examinations, with the timing of the Easter holiday ensuring there are still 5 days between the final day of classes and the proposed first day of examinations.

MOTION:

That Education Council approve the adjustment of examination dates for the 200710 term from April 12 - 19, 2007 to April 11 – 19, 2007.

ii) Repeat Course Registration

B. Pendleton explained that the Geography department has requested to be included among those departments listed in the College Calendar which place restrictions on the number of times a student may re-register for a course without special approval. This request was approved at the December 6, 2006 meeting of Deans and Division Chairs.

iii) Nursing Division memo re: Course Credit: Special Consideration

W. Low circulated copies of this memorandum addressed to Deans and Division Chairs which requests that, in relation to the Course Credit: Special Consideration policy presented at today's meeting of Education Council, and in consideration of the high quality of competency and safety skills required in nursing, an addition to the Calendar be made stating that Nursing "students are not eligible to receive Deferred Standing for any practice placement experiences or for any course where skills or competencies are continually evaluated throughout the course and/or where regular attendance is required."
