# Course Title Change

- i) PSYC 2319: Psychology of Marriage and the Family
- B. Pendleton explained that the change of course name, from Psychology of Marriage and the Family to Psychology of the Family, will make the title consistent with other courses in the Family Studies program.

## Prerequisite Change

- i) LAMS 2203 Latin America: Historyii) LAMS 2204 Latin America: Literature
- iii) LAMS 2206 Latin America in a Globalized World

The following changes were proposed:

For LAMS 2203, add LAMS 2206 to the existing list of possible prerequisites.

For LAMS 2204, add both LAMS 2203 and LAMS 2206 to the existing list of possible prerequisites. For LAMS 2206, add the following courses: LAMS 2204, AHIS 1117, ANTH 2230, ANTH 2270, SPAN 1115, SPAN 1118, SPAN 2119, SPAN 1215, SPAN 1218, SPAN 2219, SPAN 1205 to the existing list of possible prerequisites.

All prerequisites require a minimum grade of C-. R. Semmens indicated that changes do not disadvantage students in any way but rather provide more opportunity to gain entry into courses.

# Prerequisite Change

- i) PUBS 1229 Electronic Communications
- ii) PUBS 1240 Publishing Issues & Practices

K. Pawlak noted that these items arise from the significant changes made to the Publishing Program in November 2006. PUBS 1229 is a new Term Two course, which requires completion of all Term One courses, with a minimum C grade, to be listed as prerequisites. PUBS 1240 has moved to Term One from Term Two, and therefore the listing of Term One courses as prerequisites is no longer valid.

# Prerequisite Change

i) FINA 1210 Introduction to Ceramics II

The Fine Arts department has proposed that the prerequisites for this course be changed to FINA 1120 and 1140 with a minimum C grade. It was noted that FINA 1210 is completely independent of the existing prerequisite, FINA 1110: Introduction to Ceramics I in terms of technical and material development, and while both are required to progress in the program, they do not need to be taken in any particular order.

# Program Admission Requirements Change

i) Display & Design Program

K. Pawlak explained that the Display + Design department has determined that the existing entry requirement involving interview and presentation of a portfolio is not as indicative of student success as is the creative assignment which applicants are asked to complete at the time of application. Therefore the

department wishes to amend the admission requirements to include only the completion and return of the creative assignment, with the change to be implemented September 2007. Existing applicants will be notified of the change via a revised acceptance letter.
