The Program

Langara College's two-year, accelerated full-time CS Diploma in Registered Massage Therapy provides exceptional hands-on learning opportunities and covers pre-natal to geriatric care. This Continuing Studies program prepares students for the College of Massage Therapists of British Columbia's Registration Exams and a fulfilling career as a registered massage therapist.

Application Fee

International Students: \$155 CAD

Submitting Your Application

Entry to our RMT program is highly competitive. Your complete application package, including all educational documents, **must** be received before the deadline. Include all of your post-secondary transcripts, if applicable. Applications open one year before the requested intake semester. The program intakes are in September and January. Please contact the Program Coordinator with any questions.

Sep 2018 intake: **May 17, 2018** (International) | **June 13, 2018** (Domestic)

Jan 2019 intake: **September 13, 2018** (International) | **October 31, 2018** (Domestic)

Academic Requirements (continued on next page)

Successful completion of high school, with preference given to applicants who have post-secondary education including successful completion of an anatomy and physiology course from a recognized university or college.

1. Transcripts

Applicants must submit **official** educational documents to support program application. If the transcripts are in a language other than English, an official word-for-word English translation must be submitted in addition to the original transcript.

2. Complete an Introduction to Massage course

The preferred course is Langara's course, and we also accept a course from other RMT schools with similar hours (at least 12 hours long). Provide documentation of successful completion.

3. Visit to an RMT form

Students must experience a professional massage treatment session with an RMT of your choice. Please see the Visit to an RMT form for more details. The RMT must sign the form confirming that they have treated you. In addition to a massage, students must also ask at least the 3 questions on the form and write an essay on information they have received.

4. RMT Program Admission Essay Questions

Students must answer the RMT Program admission essay questions. Please answer questions completely in essay format. Please use 3-4 pages to complete the questions.

5. Professional Reference Letter

Provide a reference from someone who has known you for at least 5 years, and is not a family member. For consistency, a professional is considered to be anyone who has a BA or equivalent university or college

degree. The reference must outline the context of the relationship and must be able to attest to your characteristics of perseverance and ability to deal with stressful situations.

6. English Proficiency

Students must demonstrate English-language proficiency with one of the following:

- a. TOEFL Paper Delivered Test with a total score of 92 or higher, and a minimum of 22 in Listening, 22 in Reading, and 22 in Writing
- b. TOEFL (Internet-based) with a total score of 92 or higher and a minimum of 22 in Listening, 22 in Reading, 22 in Speaking, and 22 in Writing
- c. IELTS Academic 7.0 with no band less than 6.5
- d. CAEL 70 overall with essay 65
- e. LPI (Language Proficiency Index) Level 5, essay 26
- f. IB English A1 or A2 (HL or SL) with a score of 4
- g. Advanced Placement English Language & Composition **or** English Literature & Composition (score of 3)
- h. LET (Langara English Test) Level 3
- i. Successful completion of LEAP Level 8
- j. Successful completion of B.C. Grade 12 English or Communications 12 or equivalent with a **combined** grade of 70%
- k. Successful completion of post-secondary English or Communications course for which Langara awards transfer credit

7. Study Permit (if applicable)

International students applying from overseas are advised to check with the Canadian Embassy in their country as to the processing time for a Study Permit (formerly known as Student Authorization/Visa).

Application Status

Domestic Students

If you are accepted into the RMT Program, an acceptance letter will be sent by email approximately 15 business days after the application deadline. The acceptance letter is valid for that one specific semester only, and is not transferable to another semester

International Students

Upon sending out an Offer of Admission by email, Langara must receive all required payment, in full, within 20 business days, or the offer may be cancelled without additional notice and the seat offered to another student. International students are required to pay the tuition fee, Year-1 International Supplemental Fee, and Langara Students' Union fee for the first semester. Once the fee payment has been received, an official Letter of Acceptance will be issued to apply for a study permit (if applicable).
