

## WHAT IS THE PROVINCIAL TUITION WAIVER PROGRAM?

The program waives tuition and eligible fees for current and former children or youth in care who are studying full- or part-time below the graduate level.

#### AM I ELIGIBLE?

To be eligible for the Provincial Tuition Waiver Program, students must be studying full- or part-time below the graduate level at a B.C. public post-secondary institution; the Native Education College or an approved union-based trades training provider, and:

- Adopted through the B.C. Ministry of Children and Family Development (MCFD) or an Indigenous Child and Family Service Agency (ICFSA); or
- Formerly in the B.C. Ministry of Social Development and Poverty Reduction Child in Home of Relative Program; or
- Currently or formerly in any B.C. MCFD or ICFSA Legal Status (either while living in B.C. or while placed by MCFD or an ICFSA on an Interprovincial Placement Agreement [IPPA]) at the time they turn(ed) 19, or for at least 24 months (730 days)(consecutive or accumulated in any combination).

- Adoption
- Continuing Custody Order with a Director
- Extended Family Plan
- Interim Custody Order with a Director
- Interim Custody Order with person other than a parent •
- Permanent Transfer of Custody Order with person other than a parent
- Special Needs Agreement
- Temporary Custody Order
- Temporary Transfer of Custody Order
- Under the Guardianship of a Director Adoptions Act
- Under the Guardianship of a Director Infants Act
- Voluntary Care Agreement
- Youth Agreement

## WHAT IS THE LEARNING FOR FUTURE GRANT?


The Learning for Future Grant provides an annual grant of \$3,500 per program year to assist with additional education related costs that are not covered by the Provincial Tuition Waiver Program (e.g. textbooks, computers, supplies, etc.).

#### **AM I ELIGIBLE?**

Full-time or part-time students who meet the eligibility criteria for the Provincial Tuition Waiver Program and are enrolled in an eligible program or course that leads, or will lead, to a credential below the graduate level are eligible to receive this grant once per program year. Learning for Future Grant payments will not be issued until the student's institution is able to verify the student's enrollment in eligible studies.

- 2. By signing below, I agree that:
  - a. Providing false or misleading information on this application may result in a denial of Provincial Tuition Waiver Program and/or the Learning for Future Grant funding in the future.
  - b. If I receive Provincial Tuition Waiver Program and/or Learning for Future Grant funding, a T4A will be issued by my institution. I acknowledge that I am responsible for any tax implications resulting from my receiving this funding.
  - c. I cannot accept grant funding under the Learning for Future Grant more than once in the same program year (August 1st July 31st).
  - d. I cannot accept grant funding under both the Learning for Future Grant and the Youth Educational Assistance Fund Transition Plan in the same program year (August 1st July 31st).
  - e. If it is discovered that I received the Learning for Future Grant more than once in the same program year, or both the Youth Educational Assistance Fund Transition Plan and the Learning for Future Grant in the same program year, I will not receive the Youth Educational Assistance Fund Transition Plan or the Learning for Future Grant in the following program year. My eligibility for grant funding may be reconsidered after one full program year.
  - f. I will notify my institution immediately and in writing of any changes to my contact information, including my mailing address.
- 3. Effective the date I sign this declaration, I consent to collection, use, or disclosure of my information for the following purposes:
