Course Description, Prerequisites, and Corequisites:

This course is a 2-week (minimum 75 hour) practicum in which the student assumes the role of a food service supervisor in a food service operation, and completes the tasks required of that position. It is meant to be a vacation relief or project relief type situation. The student is still under the supervision of the Site Facilitator.

This practicum prepares students to take on the full responsibilities of an entry level Food Service Supervisor.

Prerequisite (s)

Students must achieve a minimum C grade in all of FSRV 2322, FSRV 2422, FSRV 4444 and FSRV 4323 and satisfactory completion of all other diploma program courses.

Students must have completed FoodSafe 2 to take this course.

Corequisite (s)

Students may be enrolled in FSRV 2329 in their final term concurrently with this practicum. FSRV 2329 must have been successfully completed before starting FSRV 2529

All other program requirements must be completed before registering in FSRV 2529 and the Student must have a CGPA of 2.0
