# Temporary Resident Visa (TRV)

If you are a temporary resident in Canada with valid status (that is, you have a valid study permit, work permit, or visitor record), you can apply for a new temporary resident visa to return to Canada before you leave. You can apply in Canada if:

- you are a legally admitted
- student or foreign worker
- your current temporary resident status is still valid, and your existing visa counterfoil is expired or was valid for only
- you need a new temporary resident visa to return to Canada in the near future.

### How to apply

### 1. Apply Online - to apply online you must have:

- an enrollment letter from Langara College
- proof of academic standing
- access to a scanner or digital camera to make electronic copies of your documents for uploading

#### 2. Paper Application

- get the application package
- complete the application and attach necessary documents
- submit application

\*Note: If you give an email address on your application, check it regularly for emails about your case. Some spam filters block these emails. If you are not sure if you are getting emails, check your account on a regular basis.

Biometrics- you will need to provide biometrics (fingerprints and photo) if you are submitting a study permit extension. If you have provided biometrics in the last 10 years they are still valid and you will not need to submit
