Course Code, Number, and Title: APPL 5330 Planning Studio: Sustainability

Course Format: Classroom based

Course Description, Prerequisites, Corequisites:

In this course students will prepare a comprehensive plan for a neighbourhood area, with associated land use designations and supporting policies for the planning and development of a sustainable community. The project focuses on the preparation of the components of a comprehensive neighbourhood plan for an urban area with (re)development potential. As a 'capstone' course, students will apply a wide range of planning skills and knowledge acquired during the Applied Planning Program. The project will allow students to demonstrate -- both as individuals and as teams -- their professional capabilities.

APPL 5110, 5120, 5130, 5140, 5210, 5220, 5230, 5240, all with a minimum "C" grade.

Learning Outcomes:

Students will work individually and in teams to prepare a comprehensive plan for an urban area with planning issues and (re)development potential. At the end of the course, students can expect to be able to complete the following:

- Organize and manage a planning research project to inform a planning program.
- Conduct surveys of planning topics for the area, and analyze the contextual information to identify underlying planning issues.
- Research current planning practices and principles for encouraging sustainable development for the plan preparation.
- Summarize the planning and development issues uncovered through the research, and explain how each issue will be addressed in the plan.
- Evaluate alternative approaches for promoting sustainable development and other planning principles, as relevant to the site.
- Translate an understanding of issues into practical planning proposals and policies for the subject site.
- Design a public engagement program to support the planning project.
- Prepare a study project in a series of steps, culminating in a comprehensive plan report and presentation.
